## TERMS AND CONDITIONS OF BOAT RENTALS

1. As the lessee of a boat belonging to the Ruth Lake Community Services District (RLCSD), and / or Ruth Lake Marina, (Lessor), I agree that I am fully responsible for any damages to the boat, motor, prop, and related equipment. Damage to any boat, motor, prop, or related equipment will result in loss of the deposit AND additional charges to the lessee credit card as required to effect repairs to the boat, motor, prop, and/ or equipment.
2. As the lessee of a RLCSD boat, I agree not to exceed the occupancy rating for the boat, and
3. That I will return the boat at the specified time. If the boat is not returned at the specified time, I will either be charged an hourly rate, or by the ½ day rate if another customer had the boat reserved.
4. I agree to pay a minimum cleaning charge of \$20, if the boat is returned unclean.
5. I agree that no individual will operate the boat, unless they can do so legally.
6. The undersigned agrees that the Ruth Lake Marina and the Ruth Lake Community Services District will not be liable for any damages caused by reckless or illegal operations of the rented boat and or equipment. Bow riding is illegal; death or injury caused by bow riding is the sole responsibility of the driver of the boat.
7. Any unsafe and/ or illegal operations of any vessel will result in the termination of this rental agreement, and all rental fees will be forfeited.
8. There will be no refunds on boats returned early.
9. Lessor reserves the right to refuse service to anyone.

I have carefully read, understand, and agree to the above listed Terms and Conditions, and I agree that the Operator of the leased boat will abide by all of the above Terms and Conditions.
