## **TERMS AND CONDITIONS OF PATIO BOAT RENTALS**

1. As the lessee of a boat belonging to the Ruth Lake Community Services District (RLCSD), and/or Ruth Lake Marina, (Lessor), I agree that I am fully responsible for any damage to the boat, motor, prop, and related equipment. Damage to any boat, motor, prop, or related equipment will result in loss of the deposit AND additional charges to the lessee credit card as required to effect repairs to the boat, motor, prop, and/ or equipment.
2. As the lessee of an RLCSD boat, I agree not to exceed the occupancy rating for the boat.
3. I will return the boat at the specified time. If the boat is not returned at the specified time, I will either be charged an hourly rate, or by the ½ day rate if another customer had the boat reserved.
4. I agree to pay a minimum cleaning charge of \$25 if the boat is returned unclean.
5. I agree that no individual will operate the boat unless they can do so legally.
6. The undersigned agrees that the Ruth Lake Marina and the Ruth Lake Community Services District will not be liable for any damage caused by reckless or illegal operations of the rented boat and/or equipment. **Bow riding is illegal** (everyone must remain inside the gated area while the boat is in motion); death or injury caused by bow riding is the sole responsibility of the driver of the boat.
7. **The operator of the leased boat is solely responsible for the safety and lives of everyone aboard.**
8. Any unsafe and/or illegal operations of any vessel will result in the termination of this rental agreement, and all rental fees will be forfeited.
9. There will be no refunds on boats returned early.
10. Lessor reserves the right to refuse service to anyone.
11. Please take note that upon returning the rental, we have up to 24 hours to charge you for any additional damages that are discovered. We will not charge your card without prior notification.
