1. Call to Order:

- a. The meeting was called to order by Chairman Jordan Emery at 4:00 pm.
- b. Board members present were Jordan Emery, Ben Boak, Roger Kirkpatrick, and Debra Sellman.

2. Approval of Agenda:

a. Debra Sellman motioned to approve the March 12, 2024, agenda. Ben Boak seconded the motion. Motion carried Jordan Emery, Roger Kirkpatrick, Ben Boak, and Debra Sellman.

- e. No response from Kristy Anderson from Trinity County Environmental Health Department regarding the incinerating toilets on boat leases.
- f. The Ad-Hoc meeting with STVFD and RLCSD was held on February 15, 2024. There was discussion about making a new contract between the two entities. More will be discussed at the next meeting ad-hoc meeting for which a new date has not been set.
- 9. Manager's Report and Update:
 - a. Financial-Recognize and Acknowledge Documents: No questions.
 - b. Community Hall: The new digital sign was installed at the hall on February 28th, 2024. Up-coming events for March include 16th St. Patrick's Day Dinner and 4-H Dessert auction and 23rd STVFD annual meeting. On April 5th Lance Berry will be hosting a fire class and on the 13th Lions Club Wild Game Feed.
 - c. Marina: Everything at the Marina has been going well. April 1st the marina opens for the season. The Marina will be open part-time until the 14th. On April 6th APVFD Bass Tournament will be held at the Marina.
 - d. Campground: The Campground has been quiet. The month of March the weekend boat inspections have been taking place at Ruth Rec. There will be a soft opening in the middle of April for the Ruth Rec Store. Reservations will be starting April 8th and April 15th. Campground clean-up will be starting April 1st.
 - e. Leases: Caitlin is still in contact with legal counsel regarding the leases that are in default to see what steps are next to continue with the process. Larry from HBMWD shared that the tree planters will be in the area from April 3rd to the 10th to plant fir, pine, and black oak.
 - f. Buffer Strip: Lot of down trees from the past winter storms.

10. New Matters for Board Consideration:

a. Connor Nixon from Trinity Food Outreach has reached out to the CSD for their assistance with finding a location to be able to place a 40' storage container filled with disaster relief supplies for the community when a disaster takes place. Currently, it looks like it is possible for the location to be Ruth Community Church.
