

RUTH LAKE COMMUNITY SERVICES DISTRICT Minutes for August 13, 2024 Board of Directors Meeting



1. Call to order:

- a. The meeting was called to order by Chairman Jordan Emery at 4:00 pm.
- b. Board members present were Jordan Emery, Ben Boak, Ed Johnson, Roger Kirkpatrick, and Debra Sellman.
- c. Others present were Ron Webb, Leaseholder; Dan Frasier, Trinity County BOS; Larry Raschein, HBMWD; Rick Lewis, Public; Patsy Lewis, Public; Maggie Bryant, RLCSD; Caitlin Canale, RLCSD; Cynthia Lofthouse RLCSD, and Brian Hughes, BBK Law.

2. Approval of Agenda:

a. Debra Sellman motioned to approve the agenda for August 13, 2024. Ben Boak seconded the motion. Motion carried Jordan Emery, Debra Sellman, Ben Boak, Roger Kirkpatrick, and Ed Johnson.

3. Approval of Minutes:

a. Ben Boak motioned to approve the minutes for July 9, 2024. Debra Sellman seconded the motion. Motion carried Jordan Emery, Ed Johnson, Roger Kirkpatrick, Ben Boak, and Debra Sellman.

4. Public Comment:

- a. Ron Webb leaseholder site 91 stated that 5 mph signs in Ski Cove need to be repainted. He mentioned that wet slip #35 at the marina is missing a floatation and needs attention.
- b. Rick and Patsy Lewis shared their frustration about Lease 112B, Baird, who was observed removing logs from other leases on Holly Creek Lane and damaging the road that is used by many other leaseholders and private property owners.
- 5. Supervisor's Report: Dan Frasier from Trinity County District 5 stated that he is not getting any answers from the Planning Department. Dan has spoken to a few leaseholders wanting their permits so they can move forward. At this time there are no guidelines to sign off on permits. Brian Hughes with BBK will follow up with Trinity County.

- a. Ben Boak motioned to approve the transfer lease 94C from Mick Mangrum to Fred and Shan Grundman. Ed Johnson seconded the motion. Debra Sellman abstained. Motion carried Jordan Emery, Ed Johnson, Ben Boak, and Roger Kirkpatrick.
- b. Recreational Lease Site Standards draft for Policy 6000.543 and 6000.544 was tabled to discuss further at the next meeting.
- c. Debra Sellman motioned to approve the update of Policy 7100.241, Community Hall Use Policy, and Fee Schedule, to add Southern Trinity Volunteer Fire Department as an exempt organization. Ben Boak seconded the motion. Motion carried Jordan Emery, Ed Johnson, Roger Kirkpatrick, Debra Sellman, and Ben Boak.
- d. Ed Johnson motioned to approve the surplus of pontoon boat #18. Debra Sellman seconded the motion. Motion carried Jordan Emery, Ben Boak, Roger Kirkpatrick, Ed Johnson, and Debra Sellman.
- e. There is no update for the ad-hoc meeting between STVFD and RLCSD at this time.
- f. Brian Hughes from BBK Law shared with the board the process for a lease termination for the current and future leases.

9. Manager's Report and Update:

- a. Financial-Recognize and Acknowledge Documents: No comments.
- b. Community Hall: Community breakfast was held on August 4th and will be held on September 8th.
- c. Marina: The marina has been really busy on the weekends and is starting to slow down some during the week. Labor Day weekend rentals have been reserved.
- d. Campground: All three of the campgrounds have been completely booked until after Labor Day weekend. The store has been having great sales and also slowing down now during the week.
- e. Leases: There are a few leases that will be addressed for having too many trailers on their site and there have been a few complaints about Mr. Baird removing logs from other lease sites on Holly Creek. This has been brought to the attention of the board and both items will be addressed by the District Manager.
- f. Buffer Strip: Nothing currently.

 - a. Conference with Legal Counsel Existing Litigation: Government Code § 54956.9(b): No action was taken.
 - b. Conference with Legal Counsel Anticipated Litigation: Initiation of litigation to Government Code § 54956.9(d)(4): (3 cases): A motion was made by Debra Sellman to start the procedure to terminate Lease 97A and to send a final letter with no response required back from the leaseholders to Lease 98B, 111C, and 88G for the District to take back possession of the leases. Roger Kirkpatrick seconded the motion. Motion carried Jordan Emery, Ed Johnson, Roger Kirkpatrick, Debra Sellman, and Ben Boak. The closed session ended at 6:02pm.
