

RUTH LAKE COMMUNITY SERVICES DISTRICT Minutes for February 18, 2025 Board of Directors Meeting



1. Call to Order:

- a. The meeting was called to order by Chairman Jordan Emery at 4:07 pm.
- b. Chairman Jordan Emery led the flag salute.
- c. Board members present were Jordan Emery, Ed Johnson, Debra Sellman, and Roger Kirkpatrick. Board member absent was Ben Boak. Others present were Caitlin Canale, RLCSD; and Cynthia Lofthouse, RLCSD.

2. Approval of Agenda:

a. Ed Johnson motioned to approve the agenda for February 18, 2025. Debra Sellman seconded the motion. Motion carried Jordan Emery, Ed Johnson, Debra Sellman, and Roger Kirkpatrick.

3. Approval of Minutes:

- a. Debra Sellman motioned to approve the minutes for January 14, 2025, with the correction on page 2 item (8f) adding Debra Sellman. Roger Kirkpatrick seconded the motion. Motion carried Jordan Emery, Ed Johnson, Roger Kirkpatrick, and Debra Sellman.

a. Due to the high water level the white log booms at the marina are still stuck underwater and a section of the orange ones on the right side of the marina. The left side of the dock is currently broken and tied off to the right side dock. Waiting for water to clear up a little before the diver comes out to work on the dock. The new white log booms are being welded on in Fortuna and hopefully will be done soon from JB Fabrication.

- c. Ed Johnson motioned to update Policy 6000 Recreational Lease Site Standards in section 6000.26, Insurance. Adding, "In the event of a fire, you are responsible for any debris removal from your lease site." Roger Kirkpatrick seconded the motion. Motion carried Jordan Emery, Debra Sellman Roger Kirkpatrick, and Ed Johnson.

- f. Debra Sellman motioned to approve CPI increase for 2025. Roger Kirkpatrick seconded the motion. Motion carried Jordan Emery, Ed Johnson, Debra Sellman, and Roger Kirkpatrick.
- g. Discussion of the letter from Kristy Anderson of Trinity County Environmental Health Division about the CSD requesting a waiver to allow installation of three pit privies on the boat in only leases.
